

TERMS & CONDITIONS
ARMADA DANDENONG PLAZA
VALENTINE'S DAY PROMOTION 2019

1. Information on how to enter and prizes form part of these Terms & Conditions. Participation in this Armada Dandenong Plaza Valentine's Day Promotion ("Promotion") is deemed acceptance of these Terms & Conditions.

ELIGIBILITY

2. Subject to condition 3, this Promotion is open to all Armada Dandenong Plaza shoppers. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to all Terms & Conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to this Promotion.
3. The following are ineligible: (i) employees of the Promoter or any of the Promoter's retailers or agencies that are associated with the Promotion; (ii) the spouse, defacto spouse, parent, child or sibling (whether natural or by adoption) of an excluded employee; and (iii) any person who the Promoter has previously notified is not permitted to enter the Promoter's promotions.

PROMOTION PERIOD

4. This Promotion is only open Australian Eastern Standard Time ("AEST"):
From 11am on Monday 11 February 2019 until all love hearts are found ("Promotion Period").

HOW TO ENTER

due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law (a) to disqualify any entrant; or (b) to modify, suspend, terminate or cancel the Promotion, as appropriate.

18. The Promoter's decision is final and no correspondence will be entered into.
