

## Terms & Conditions

### ARMADA DANDENONG PLAZA

#### BLACK FRIDAY 2021 – WIN A \$500 ARMADA DANDENONG PLAZA FASHION GIFT CARD

1. Information on how to enter and prizes form part of these Terms & Conditions. Participation in this Armada Dandenong Plaza Black Friday 2021 – Win a \$500 Armada Dandenong Plaza Fashion Gift Card Competition (“Competition”) is deemed acceptance of these Terms & Conditions.

#### ELIGIBILITY

2. Subject to condition 3, this Competition is open to all Armada Dandenong Plaza shoppers. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to all Terms & Conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to this Promotion.
3. The following are ineligible: (i) employees of the Promoter or any of the Promoter’s retailers or agencies that are associated with the Promotion; (ii) the spouse, defacto spouse, parent, child, or sibling (whether natural or by adoption) of an excluded employee; and (iii) any person who the Promoter has previously notified is not permitted to enter the Promoter’s promotions.

#### PROMOTION PERIOD

4. This Competition is only open Australian Eastern Standard Time (“AEST”): 9.00am Monday 22 November 2021 to 9:00pm on Friday 26 November 2021 (“Competition Period”). The prize draw will take place on Monday 29 November 2021 after the Competition Period at Centre Management. Winners will be drawn at random.

#### HOW TO ENTER

5. To enter this Promotion, eligible individuals must make a minimum \$30 spend in one transaction (“Qualifying Spend”) at any Armada Dandenong Plaza fashion or accessory retailer. Refer to list of fashion and accessory retailers at the end of this document.
6. Customers must then visit the Armada Dandenong Plaza website ([www.armadadandenongplaza.com.au](http://www.armadadandenongplaza.com.au)) and submit their details along with a copy of their receipt.
7. Customers must sign up to the Armada Dandenong Plaza email mailing list to enter.
8. Receipts must be an official store receipt with the words “TAX INVOICE” clearly stated.
9. Customers can enter multiple times within the campaign period per every new Qualifying Spend.

#### LIMITS ON ENTRY

10. Limit of one entry, per qualifying spend, i.e. if a customer has spent \$200 at Ally Fashion in one transaction, they will only receive one entry.
11. The spend must be made within the Competition Period.
12. Multiple receipts to make up the Qualifying Spend will not be accepted.
13. Credit card/eftpos receipts, layby payments (unless final payments), bank statements are not considered valid receipts for this Promotion.
