

Terms & Conditions

ARMADA DANDENONG PLAZA

FACEBOOK FRIDAY FREEBIES COMPETITION

1. Information on how to enter forms part of these Terms & Conditions. Participation in this Armada Dandenong Plaza Facebook Friday Freebies Competition ("Competition") is deemed acceptance of these Terms & Conditions.

ELIGIBILITY

3. Subject to condition 3, this Competition is open to all Armada Dandenong Plaza shoppers. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to all Terms & Conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to this Promotion.
4. The following are ineligible: (i) employees of the Promoter or any of the Promoter's retailers or agencies that are associated with the Promotion; (ii) the spouse, defacto spouse, parent, child or sibling (whether natural or by adoption) of an excluded employee; and (iii) any person who the Promoter has previously notified is not permitted to enter the Promoter's promotions.

COMPETITION PERIOD

5. This Competition is valid Australian Eastern Standard Time ("AEST") or Australian Eastern Daylight Time ("AEDT") weekly from 6:30pm Fridays until 11:59pm on the following Thursday ("Competition Period") when the Competition is run.
6. The Armada Dandenong Plaza Facebook Friday Freebies Competition is a weekly competition, however is not guaranteed to run every single week of the year.

HOW TO ENTER

GENERAL

Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.

If this Promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law (a) to disqualify any entrant; or (b) to modify, suspend, terminate or cancel the Promotion, as appropriate.
