

Terms & Conditions
ARMADA DANDENONG PLAZA
JANUARY SCHOOL HOLIDAYS – FOOST COOKING CLASSES

1. Information on how to enter forms part of these Terms & Conditions. Participation in this Armada Dandenong Plaza January School Holidays – Foost Cooking Classes Promotion (“Promotion”) is deemed acceptance of these Terms & Conditions.
2. This promotion is only available at Armada Dandenong Plaza, corner McCrae & Walker St, Dandenong VIC 3175.

ELIGIBILITY

3. Subject to condition 3, this Promotion is open to all Armada Dandenong Plaza shoppers. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to all Terms & Conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to this Promotion.
4. The following are ineligible: (i) employees of the Promoter or any of the Promoter’s retailers or agencies that are associated with the Promotion; (ii) the spouse, defacto spouse, parent, child or sibling (whether natural or by adoption) of an excluded employee; and (iii) any person who the Promoter has previously notified is not permitted to enter the Promoter’s promotions.

PROMOTION PERIOD

5. This Promotion is valid Australian Eastern Standard Time (“AEST”) from Monday 18 January 2021 to Friday 22 January 2020 from 11am – 3pm daily (“Promotion Period”) on Level 2, Centre Court.

HOW TO PARTICIPATE

6. To participate in the Foost Cooking Classes, eligible individuals must make a booking by calling the Information Desk on (03) 9767 2000 and provide their details.
7. Customers must choose and book a time slot for the Foost Cooking Classes. There are 6x sessions per day with maximum capacity of 16 kids per session.
8. Session times are 11.00am, 11.45am, 12.30am, 1.15pm, 2.00pm and 2.45pm.
9. Each session runs for 20 minutes.
10. Customers must arrive at the Foost Cooking Classes activation at least 5 minutes prior to their session time.
11. Customers must sign up to the Armada Dandenong Plaza email mailing list upon booking.

LIMITS ON ENTRY

12. Limit of one child/family per session per day.

GENERAL

13. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant’s identity, age and place of residence) and to disqualify any entrant who submits an entry that is not in accordance with these Terms and Conditions or who tampers with the entry process. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.

If this Promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law (a) to disqualify any entrant; or (b) to modify, suspend, terminate or cancel the Promotion, as

appropriate.

15. The Promoter's decision is final and no correspondence will be entered into.
