

Terms & Conditions
ARMADA DANDENONG PLAZA
JANUARY SCHOOL HOLIDAYS GIFT WITH PURCHASE PROMOTION

1. Information on how to enter forms part of these Terms & Conditions. Participation in this Armada Dandenong Plaza January School Holidays Gift with Purchase Promotion (“Promotion”) is deemed acceptance of these Terms & Conditions.
2. This promotion is only available at Armada Dandenong Plaza, corner McCrae & Walker St, Dandenong VIC 3175.

ELIGIBILITY

3. Subject to condition 3, this Promotion is open to all Armada Dandenong Plaza shoppers. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to all Terms & Conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to this Promotion.
4. The following are ineligible: (i) employees of the Promoter or any of the Promoter’s retailers or agencies that are associated with the Promotion; (ii) the spouse, defacto spouse, parent, child or sibling (whether natural or by adoption) of an excluded employee; and (iii) any person who the Promoter has previously notified is not permitted to enter the Promoter’s promotions.

PROMOTION PERIOD

5. This Promotion is valid Australian Eastern Standard Time (“AEST”) from 9.00am Monday 11 January 2021 until 9.00pm on Friday 15 January 2020 (“Promotion Period”) or while stocks last.

HOW TO ENTER

6. To enter this Promotion, eligible individuals must spend \$30 or more at the below list of retailers at Armada Dandenong Plaza within the Promotion Period.

 - c. Smiggle
 - d. Spendless Shoes
 - e. Williams Shoes
7. The \$30 spend (or more) must be made in one transaction.
8. Lay by purchases (unless they are final payments), ATM withdrawals, and credit card receipts are not considered valid receipts.
9. Receipts must be an official store receipt with the words “TAX INVOICE” clearly stated.
10. Customers must then visit the Information Desk on Level 2, opposite Daiso, to present their receipt/s, verifying their purchase/s.
11. Receipts will be stamped/struck with a highlighter by Information Desk staff and handed back to the customer.
12. Customers must sign up to the Armada Dandenong Plaza email mailing list to receive a gift.
13. Customers may enter multiple times providing the spend is made on the same day and new receipts are provided.

LIMITS ON ENTRY

14. Limit of one gift per person per eligible spend. I.e. A customer that spends \$200 at one participating retailer within the Promotion Period will only receive 1 x School Holiday Gift.

15. The spend of \$30 must be made on the day to receive a Gift.

GIFT

16. The gift is 1 x Funbox Kids Backpack.
17. The Gift cannot be redeemed for cash.
18. A total of 600 x gifts are available. Once this amount has run out, the promotion is deemed concluded.

GENERAL

19. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age and place of residence) and to disqualify any entrant who submits an entry that is not in accordance with these Terms and Conditions or who tampers with the entry process. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.

If this Promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law (a) to disqualify any entrant; or (b) to modify, suspend, terminate or cancel the Promotion, as appropriate.
21. The Promoter's decision is final and no correspondence will be entered into.

Any cost associated with accessing the promotional website (Facebook), whether via a standard computer or mobile device is the entrant's responsibility and is dependent on the Internet service provider used.
